# 7. Open forum/general discussion distributing the preliminary Electric System Study performed by Sargent & Lundy. INFORMATION/DISCUSSION/ACTION (D. Gordon)

Mr. Gordon reported the preliminary Electric System Study by Sargent & Lundy has been provided to everyone for review and a meeting is scheduled for January 30<sup>th</sup>.

Mr. Panetta's discussion of the report included:

- Problem with Transformer #1 has been addressed and repaired with a new report from Potomac Testing due shortly.
- Concerns about pole-top transformer loadings with additional evaluation needed; recommend thermography during the peak season; Bay Avenue and Cedar Avenue pole tops are being changed to stainless steel if showing signs of rust.
- Growth in the area will create 8.5% margin on a single transformer at the substation and recommending replacement in the next three years; also recommend upsizing the transformers; lead time is six to eight months.
- University of DE wind turbines grounding concerns need to be checked.
- Recommend 9 megawatts of battery, 1 megawatt of solar and smart meters.
- Estimate that 50% of cars in Lewes will be electric vehicles in 10 years.

Mr. Kennedy requested additional information from Sargent & Lundy regarding the wind turbines, electric vehicles in our service area in comparison to Columbus, Ohio, and the transformer distribution system as mentioned in the study.

- ➤ Absentee ballots available on April 14<sup>th</sup>.
- ➤ BPW office will be open on a Saturday, date to be determined, 9:00 A.M. to 12:00 Noon for voters to register. This includes all who receive BPW services.
- Last date to register is April 24th, absentees votes by May 8<sup>th</sup>, election day will be May 9<sup>th</sup>.
