- Kuhn Construction on-site constructing sludge drying beds for Lewes BPW.
- 10/6/20 Performed recovery clean on train #4. No deficiencies noted.
- 10/7/20 Darrin Gordon onsite to escort incoming operations group Inframark for a site visit.
- 10/12/20 Breakwater Construction installed four 6" replacement isolation valves on the membrane air headers.
- 10/13/20 WMES staff replaced belts on EQ pumps 1&3.
- 10/19/20 Incoming operations group Inframark onsite to begin 2 week transition and turnover of plant operations from WMES.
- 10/20/20 Power-Trans onsite to replace grit auger.
- 10/22/20 Removed dry sludge from beds 1-6.
- 10/31/20 WMES end of operations contract. Inframark has assumed operational control.
