- Headworks-Meetings with Inframark, BPW, Keystone and Hills Industrial to discuss the Equalization Pump control panel replacement project occurred during July and August. Inframark has piped up a temporary solution utilizing a dewatering roll off container. Inframark met with BPW and GMB regarding Headworks Project.
- Filters- UF Train 4 de-ragged and returned to service 3-8-2021. UF Train 1 de-ragged and returned to service 4-19-2021. De-ragging of UF Train 2 complete 5-28-2021. UF Train 3 de-ragged and returned to service 7-21-2021.
- Pump Station 4 Emergency Generator and Transfer Switch are in need of replacement. Inframark is getting three quotes. Pump Station 8 Generator Transfer Switch is in need of replacement. Inframark is getting three quotes. Pump 1 at PS4 became clogged again on 8-13-2021. Inframark is working with BPW to provide a solution.

Critical Issues

- Covid- Inframark is following CDC recommendations to ensure undisrupted service to the BPW and the Lewes community.
- Condition of headworks screening equipment is in critical need of repair to decrease excessive ragging of UF membranes.






Trends Influent vs Precipitation Trend Previous 12 Months
