## **RESOLUTION 11-007**

## A RESOLUTION OF THE BOARD OF DIRECTORS OF THE LEWES BOARD OF PUBLIC WORKS ESTABLISHING THE BOARD'S POSITION ON THE DISPOSITION OF THE BOARD OF PUBLIC WORKS ELECTRIC UTILITY

WHEREAS, The Board of Public Works of the City of Lewes, Delaware ("BPW") hired J.W. Wilson & Associates, Inc. and Whitfield Russell Associates ("Consultants") to provide management consulting services in performing an evidence-based analysis of all available options for cost-effectively providing utility services to BPW customers.; and

WHEREAS, the Board has reviewed this report and other salient factors regarding the question of all available options for cost-effectively providing utility services to BPW customers; and

WHEREAS, the Board members on September 28, 2011, discussed the following as a proposed public position on the question of selling one or more of the BPW utilities:

**NOW, THEREFORE, BE IT RESOVED** BY THE BOARD OF DIRECTORS OF THE LEWES BOARD OF PUBLIC WORKS, IN SESSION MET THIS **28TH** DAY OF **SEPTEMBER, 2011**, THAT:

Section 1. Upon review and consideration of the <u>Report To the Board of Public Works</u> of the <u>City of Lewes, DE Analysis of Available Options for Providing Cost-Effective Utility</u> <u>Services</u> report, dated June 2011, and related factors including the need for a reliable source of electricity, the economic conditions of the Board of Public Works, the City, and its inhabitants, the record of reliability that the electric system has delivered, the Board of Directors of the Lewes Board of Public Works find that, it is not in the best interest of the health, safety, and welfare of the City to sell, in whole or in part, the Lewes Board of Public Works' electric utility.

**Section 2.** If any provision of this Resolution shall be deemed or held to be invalid or unenforceable for any reason whatsoever, then such invalidity or unenforceability shall not affect any other provision of this Resolution which may be given effect without such invalid or unenforceable provision, and to this end, the provisions of this Resolution are hereby declared to be severable.

**Section 3.** This Resolution shall take effect immediately upon its adoption by the Board of Directors of the Lewes Board of Public Works.
