- Headworks- Inframark continues to utilize the dewatering roll off container to capture screening while the Lipactor is offline.
- Oxidation Ditch-Cracks were identified in the concrete tank walls. BPW issued PO for work to be completed spring 2023. Waiting to hear back from vendor for start date but looking at a start date of no later than the week of 5/15/2023.
- Filters- De-ragging UF Train 4 will be completed during the week of 4-24-2023. UF Train 1 will be immediately taken offline for de-ragging upon restoring of UF Train 4 to service.
- A rental emergency generator is online at Pump Station 4 while plans for a permanent solution are being evaluated. Hills to complete PS3 pump and valve replacement starting 4/24/2023. Harry Caswell to replace wet well piping at PS2 starting 4/24/2023.

Critical Issues

- Covid- Inframark is following CDC recommendations to ensure undisrupted service to the BPW and the Lewes community.
- Condition of headworks screening equipment is in critical need of repair or replacement to decrease excessive ragging of UF membranes.
- Spare pumps are not in stock for PS11, PS15, PS16, PS17, PS17B, PS18 and PS32. Inframark does not have maintenance records for existing pumps. Based on recommendations made in Severn Trent's 2016 Annual Report, most pumps were in need of replacement within five years. We have found no evidence that these pumps had been replaced during the past five years. Many pump station control panels are in need of repair or replacement including PS1, PS2, PS5, PS6, PS7, PS9, PS10, PS11, PS12, P13, PS14, PS15, PS16, PS17, PS18, PS33, PS74 and PS83.





Corrective Maintenance, Repair and Activities

- WWTP- Digester Building-Replaced sump pump to lower-level pump room.
- WWTP- Process Building-Replaced 24-Hour Effluent Composite Sampler with new Hach unit.
- WWTP- Process Building-Replaced Air Relief Valve tree to UF Train 1 downstream of permeate pump.
- WWTP- Headworks Building- Replaced level pressure transducer to 2mm screen.
- WWTP- Headworks Building- Pump Room exhaust fan had no power. Inframark ran a new conduit, pulled wire and connected fan to a spare breaker to restore power.
- PS15- Replaced Pump Start float switch.
- PS8- Replaced VFD to Pump 2.
- PS8- Fidelity Power onsite to service and inspect emergency generator and automatic transfer switch.
- During the month, Inframark completed routine preventive maintenance activities as recommended by equipment manufacturers and required by plant procedures. Maintenance activities are tracked utilizing a computerized maintenance management software (eMaint).
